Sir:

At the Governor's Conference on Friday, October 18, I brought you a folder of photos to show you the roads damaged in Johnson County. A young lady assured me that she would get them to you.

The attachment shows our excessive debris for our size county in contributing to our damaged county roads. Because of the amount of debris the state is picking up, our debris estimate wasn't final when we applied for the HEAL Program. The HEAL Program for us is at \$7,450,000 with the Town of Mountain City and water at \$1,250,000 and Brownlow Water Utility at \$200,000. So, we should be returning or not using \$6,000,000 for debris removal.

We have, to date, spent \$757,000 for contractor payments; \$123,202 for road tiles; and \$785,262 for gravel. At some point, we should get reimbursed from FEMA. When?

Today, November 14, 2024, our County made an interfund loan from General Debt Service for \$1,531,672 to our road department to pay contractors. We put our Road Superintendent on notice that he county highway department is out of funds.

We will only be able to make payroll as, unfortunately, now if we have more costs of pushing snow, we are broke. The morning low temperature of Tennessee to 20 degrees and day-time high not reaching 30 degrees what work, time and gravel to make our roads passable will also be at a loss. Our bridge loss is at five.

In talking to our Road Superintendent to put our roads back, we're looking at least \$18-\$20 million, being a conservative estimate.

Please, we need help. Thank you.
